- POPP DENTAL SUPPLY, LLC will always strive to fill your order quickly and correctly. If there is any uncertainty regarding the items received, please call out Customer Service Department before opening any product packaging.
- If for any reason you are not satisfied with your order, simply return your order WITH A COPY OF THE INVOICE WITHIN 30 DAYS of the receipt of goods for a full credit or exchange. Please provide a brief description of the reason for return. For any items returned after 30 days from purchase, POPP DENTAL SUPPLY, LLC reserves the right to assess a 20% restocking fee.
- Claims for shortages, defects or miss-filled items must be made WITHIN SEVEN (7) DAYS after receipt of goods. All products must be returned in sellable condition or credits will not be issued.
- We may be able to provide you with any product whether it is listed in our catalog or not. These items not listed in our catalog and ordered on your behalf may be considered “SPECIAL-ORDER ITEMS”. **THESE SPECIAL-ORDER ITEMS ARE NOT RETURNABLE FOR CREDIT.**
- Except for the first three orders and unless otherwise determined, orders are shipped on open account, subject to credit approval, with NET 30 terms. We also accept VISA and Mastercard.
- All local orders will receive a handling/processing charge of \$4.95—UPS accounts will be \$8.95. Moreover, all orders shipped via common carrier (ie: UPS) may be subject to the actual shipping charge depending on delivery zip code and/or weight of items ordered.
- POPP DENTAL SUPPLY, LLC honors all manufacturer’s warranties, according to the conditions and limitations of each company.
- All handpiece rebuilds carry a 90-day warranty, including parts and labor. Complete re-builds include all turbine parts and bearings. Outer casings, chucks, air and water tubes and threading are extra. Please note our maintenance conditions outlined in the Handpiece Repair Section.
- Opened handpieces and all small equipment will be repaired or replaced in accordance with the manufacturer’s warranties but are **NOT RETURNABLE FOR CREDIT**, in accordance with the F.T.C. Truth in labeling regulations.
